Minutes of the Regular Meeting of The Council of the Rural Municipality of Fisher held on Wednesday, February 2, 2022 via teleconference.

Constable Mike Garton reported on monthly stats for the area. Two new hires for the office in Fisher Branch Alexis Vierra and Meridith Krawec. 325 East was closed due to the recent blizzard.

Michael McCandless

Michael McCandless attended Council via teleconference. Discussion of TLE took place. Council is in favor of obtaining servicing agreements with Peguis First Nation before properties convert to reserve status. TLE agreements are not mandatory. All zoning and development requirements need to be met before reserve status is imposed. The Province has amended the planning act which means all appeals can be made to the Planning Board. The Municipality has to be formally advised in writing about reserve status.

Some topics such as school taxes were brought up – school taxes cannot be part of the money that the RM receives, usually service fees are equal to property taxes only. It will be voluntary for TLE to contribute to school taxes. Closing of municipal roads can be done without consent by expropriation. CAO to contact Myrna Heffernan, of Peguis TLE committee, to see if she knows the status of their request.
