The Fisher Watershed District, Reeve Pyziak to stand as Chair. CAO to write Gord Fuz and Armand Belanger about citizen representation.

Joseph Gardner made a presentation on cover crops which was very informative. The District is looking into larger scale projects in 2022.

On January 13, 2022 there is a webinar with David Hays on water Licencing.

West Interlake Watershed District – Councillor Nevakshonoff is the new Chair of the SwanCreek Watershed District and the Vice Chair of the West Interlake Watershed District. There is a high emphasis on cover crops in that region. The question of expenses came up at the board meeting. Who pays for any costs incurred to attend meetings? Reeve Pyziak stated that all costs are covered by the East Interlake Watershed District, as should West Interlake cover all costs incurred. CAO to write letter to West Interlake.
