Burning within the limits of the RM of Fisher

All burning is prohibited unless accompanied by an approved Permit by the Ward Councillor and/or the Fire Chief.

Burning is permitted without a permit only if:

1. Any fire that is set is in an enclosed container for the purpose of burning garbage. While this is being burnt, a responsible person should monitor the fire to ensure that it does not get out of control.
2. Any fire that is set in an enclosed container or located in an area of dirt/sand that has been set for cooking or warmth and would normally be considered a "camp fire" While this is being burnt, a responsible person should monitor the fire to ensure that it does not get out of control.

BY-LAW NO. 1188/20

BEING A BY-LAW TO REGULATE BURNING WITHIN THE LIMITS OF THE RURAL MUNICIPALITY OF FISHER

WHEREAS Section 232 (1) (a) and (i) of The Municipal Act, L.M. 1996, C58 Chap M225 provide as follows:

232(1) A Council may pass by-laws for municipal purposes respecting the following:

A.) the safety, health, protection and well being of people, and the safety and protection of property;

(i) preventing and fighting fires;

AND WHEREAS the Council of the Rural Municipality of Fisher deems it desirable to regulate the setting of fires and burning within the limits of the Rural Municipality of Fisher;

NOWHEREFORE be it and is hereby enacted as a by-law of the Rural Municipality of Fisher, in council duly assembled as follows;

1. Authority having jurisdiction means the Municipal Council and the duly appointed agents thereof.
2. **THAT** burning is prohibited in The Rural Municipality of Fisher except where approval, in the form of an authorized Burning Permit, has been obtained. All burning permits are issued subject to the conditions stated on the Permit.
3. **THAT** applications for Burning Permits shall be made at the Municipal Office. The Permit is valid until endorsed by the authority having jurisdiction.
4. **THAT** no cost shall apply in obtaining a burning permit and all conditions as stated on the burn permit must be adhered to.
5. **THAT** the following will be exempted from obtaining a permit:
 - i.) Any fire that is set in an enclosed container for the purpose of burning garbage. While this is being burnt, a responsible person should monitor the fire to ensure that it does not get out of control.
 - ii.) Any fire that is set in an enclosed container or located in an area of dirt/sand that has been set for cooking or warmth and would normally be considered a "camp fire" While this is being burnt, a responsible person should monitor the fire to ensure that it does not get out of control.
6. The Fire Chief for the Rural Municipality of Fisher will be consulted for large burns i.e.: buildings, brush piles, fields or anything as Ward Councillor sees fit.
7. **THAT** any person who contravenes a provision of this by-law is committing an offence and will be fined:
 - a.) one hundred dollars (\$100.00) plus, costs for the first offence;
 - b.) five hundred dollars (\$500.00) plus, costs for the second offence;
 - c.) one thousand dollars (\$1000.00) plus, costs for the third offence; and"Plus, costs" are defined and listed on "Schedule A" attached.
8. Unpaid fines, or any portion of unpaid fines, be referred to a collection agency after (3) months.

9. When necessary the Police department will be notified and possible charges can be implemented under the Wildfires Act and any other Act under Provincial or Federal legislation as they see fit.

10. **THAT** burning Permits are required year-round in The Rural Municipality of Fisher.

11. **THAT** this By-Law shall come into force and task effect immediately from the passing thereof.

12. This By-Law repeals by-law **1145/12** and amendment **1163/14**.

Purpose

The Rural Municipality of Fisher has developed our landfills with environmental and social considerations in mind. They were designed and built to ensure the continued safety of those on site and of the surrounding environment.

The Rural Municipality of Fisher strives to provide an environmentally safe landfill for its ratepayers in a fair, equitable and cost-effective manner.

Scope

This policy applies to all users of the Transfer Sites and the Disposal Facility, located near the hamlet of Poplarfield, in the Rural Municipality of Fisher.

Definitions

Ashes means the residue from the burning of wood, coal, coke and like materials, for the purpose of cooking, heating buildings and disposing of combustible materials.

Bag means a clear flexible containment device with a single opening, not measuring more than 26 inches x 36 inches in size.

Bulky Wastes means large items of refuse including appliances, furniture, auto parts and large crates, each not exceeding 45 kilograms in weight, tree cuttings not exceeding 100 millimetres in diameter in bundles not exceeding 35 kilograms in weight.

Burnables means "combustibles", consisting of miscellaneous burnable materials such as paper, rags, cartons, boxes, wood shavings/packing material.

CAO means the individual assigned by by-law to the position of Chief Administrative Officer or the Municipality.

Compost means the same as 'Yard Wastes'.

Construction and Demolition Wastes means the waste 'building' materials and rubble resulting from the construction, remodeling, repair, demolition or destruction by fire or 'buildings' and other structures, and the installation, repair or removal of pavement, cement, and like works.

COUNCIL POLICY

Council means the duly elected Council of the Municipality.

Custodian means the Municipal employee who manages the Facility.

Facility means the Solid Waste Disposal Grounds/Landfills/Transfer Stations operated by the Rural Municipality of Fisher.

Grounds shall have the same meaning as facility.

Hazardous Waste means any waste that may present a hazard to a person in contact with such wastes and includes, but is not limited to, wastes such as propane cylinders, petroleum distillates, light fuels, household waste paints, caustics, drugs, acute hazardous waste chemicals, waste crankcase oils and lubricants, inorganic chemicals, halogenated pesticides and herbicides, non-halogenated organic pesticides and any other wastes of pathological, explosive, highly flammable, radioactive, toxic or acidic in nature.

Household Waste means all animal and vegetable waste, whether liquid or solid including food packaging, matter with residual food materials resulting from the handling, preparation, cooking and serving of food in households, unusable clothing, sweeping and all waste materials capable of being consumed by fire such as wood excelsior, bedding, rubber; leather, plastic, metals, ceramics, glass and yard wastes.

Industrial Waste means wastes arising from, or incidental to the manufacture, processing or like processes and manufacturing operations and includes wastes such as putrescent garbage from food processing, plants and condemned foods and produce.

Large Metallic Waste means any piece of metal or large crate weighting 45 kilograms or more including automobile wreckage or travel trailer wreckage.

Ratepayer means an owner of real property shown on the Municipality's tax roll, and/or a person authorized by an owner of real property.

Re-useables means items that are made of metal or real wood.

Recyclable means any item of household waste that is eligible for funding under the Manitoba Product Stewardship Program and deemed by the Municipality to be separated from the Solid Waste Stream.

Solid Wastes or Refuse means the useless, unwanted or discarded solid materials resulting from normal community activities.

Yard Waste means yard rubbish consisting of pruning, grass clippings, weeds, leaves, general garden wastes, exclusive of solid wastes otherwise classified herein.

COUNCIL POLICY

Waste Management Policy Guidelines

Only authorized users can access and deposit waste at a Waste Disposal Facilities/Grounds and may do so only in accordance with the following requirements/guidelines:

1. No person shall deposit or cause to be deposited waste upon any public or private property in the Municipality, including a highway.
2. Waste may only be deposited at the facility on the days and during such hours of operation as the Municipality may from time to time determine and Set by resolution.
3. All persons using the Facilities shall follow the directions provided by the Custodian.
4. If requested, the authorized user must demonstrate the nature and type of the waste to be deposited. The Custodian may otherwise refuse entry to the Facility..
5. Waste must be deposited upon, immediately adjacent to, or as near as is reasonably possible only as and where directed by the Custodian.
6. Re-usable wastes must be deposited within the separate area of the Facility designated by the Municipality for the depositing of such waste.
7. Recyclable wastes must be deposited within the separate area of the Facility designated by the Municipality for the depositing of such waste.
8. Yard Waste must be deposited within the separate area of the Facility designated by the Municipality for the depositing of such waste.
9. Depositing of rubber tires will require removal of the rims. The rims shall be deposited in the appropriate location for metallic waste and the rubber tire in the area designated by the Municipality for tires.
10. No Facility in the Municipality shall accept 'Large Metallic Waste'.
11. No Facility in the Municipality shall accept 'Hazardous Waste'.
12. Loads containing special waste or unacceptable waste may be refused.
13. Authorized users must pay the applicable fees as set out in Procedure for Tipping Fees and Schedule 'A'.
14. Any person causing a disturbance in or near a Facility will be reported to the Office and may have their privileges to the Facility revoked. This includes:
 - i. fighting, screaming, shouting, swearing, using insulting or obscene language

- ii. being drunk
 - iii. impeding or molesting other persons
15. Any person utilizing the Facilities, and operating a motorized vehicle shall drive in a safe and responsible manner.

Procedure

Tipping Fees

1. The Custodian will determine if there is a fee for waste brought to the Facility.
2. For designated waste, the Custodian will determine the fee based on 'Schedule A'.
3. The Custodian will complete the Tipping Fee Form as attached 'Schedule B'.
4. The Custodian will maintain a daily record of all charges for tipping fees.
5. The Custodian will submit any completed Tipping Fee Forms on a daily basis to the CAO at the Municipal Office.
6. Fees determined by the Custodian shall be invoiced by the Rural Municipality. Invoices issued will be payable within 30 days of the date of the invoice. Invoiced Fees, not paid after 30 days, will be collected in the same manner as a tax may be collected or enforced under the Municipal Act.
7. The Municipality reserves the right to make adjustments to the provided details of assessment, collection, and handling fees as it deems necessary.

Site Access

1. All vehicles must stop at the disposal site or waste transfer station entrance.
2. The Custodian is required to:
 - meet each person at the entrance,
 - record the vehicle licence plate and ask for their address,
 - ask what they are dropping off and direct the person to the applicable area,
 - emphasize "NO STARTING FIRES",
 - monitor where person is dropping off waste/assist as required.

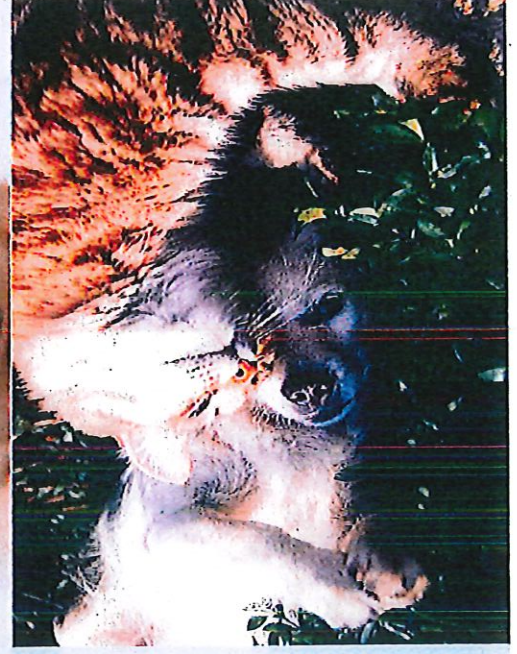

Owners

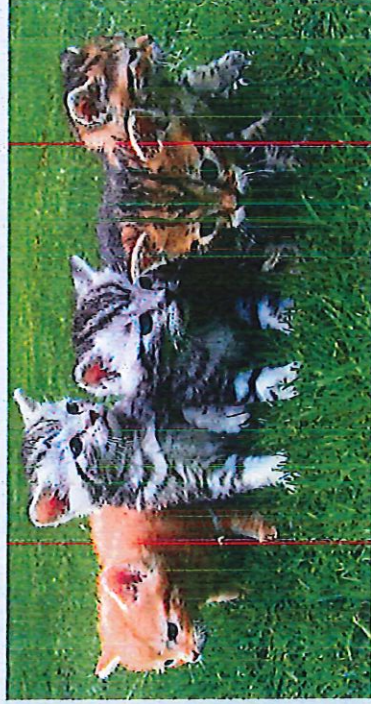
No owner shall:

- Permit their cat or dog to run at large
- Permit their dog to bark, howl or in any other way unduly disturb the quiet of any person
- Permit their cat or dog to defecate on any public or private property
- Permit their dog to pursue, bite, wound or worry any person or animal
- Permit their cat or dog on any school ground, playground or public park
- Permit their dog on public property (including parkland area) unless the dog is on a leash that does not fully extend any longer than six (6) feet

No person shall own, harbour, keep or have in their possession, or control on their premises, more than three (3) dogs over the age of four (4) months and no more than five (5) cats over the age of four (4) months regardless of the number of people who may be inhabiting the premises.

Full By-Law No. 1156/13 available at the Rural Municipality of Fisher Office

The owner of a cat shall not permit the cat to be outside of owner's premises unless the said cat is under the immediate charge and effective control of a person competent to control it



License Requirement

As of August 1st, 2017

- All dogs must be licensed and have a collar and tag
- Any dog without a license tag will be considered a wild animal and be removed from town without looking for the owner
- All cats must have an LUD tag to enable any person finding the cat to identify and contact the owner
- Any cat without a tag will be considered a WILD cat

Impoundment Fees

Any dog, cat, or other domestic pet apprehended running at large or for any other reason, will be impounded by the animal control officer.

Impoundment fees are as follows:

- First impoundment (Flat Fee): **\$100.00**
- Each day of impoundment: Add **\$20.00**
- Second impoundment if it occurs within 12 months of the first offence (Flat Fee): **\$200.00**
- For each day of impoundment: Add **\$20.00**

TIPPING FEES

Tipping Fees apply for bringing household waste to the Fisher Branch and Hodgson transfer stations. The cost is \$2.00 per bag; stickers are available for purchase at the RM of Fisher office. Bags must have a sticker in order to be accepted at the transfer stations.

EFFECTIVE April 1, 2019

All Household garbage must be in clear bags.

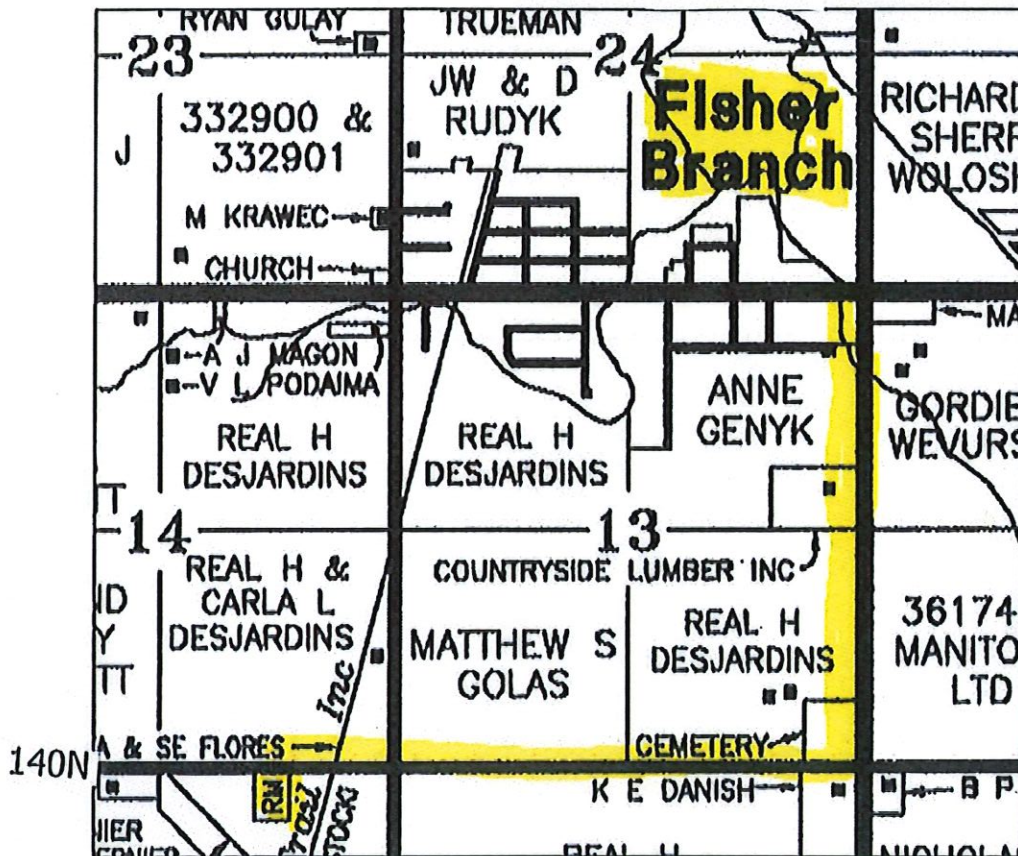

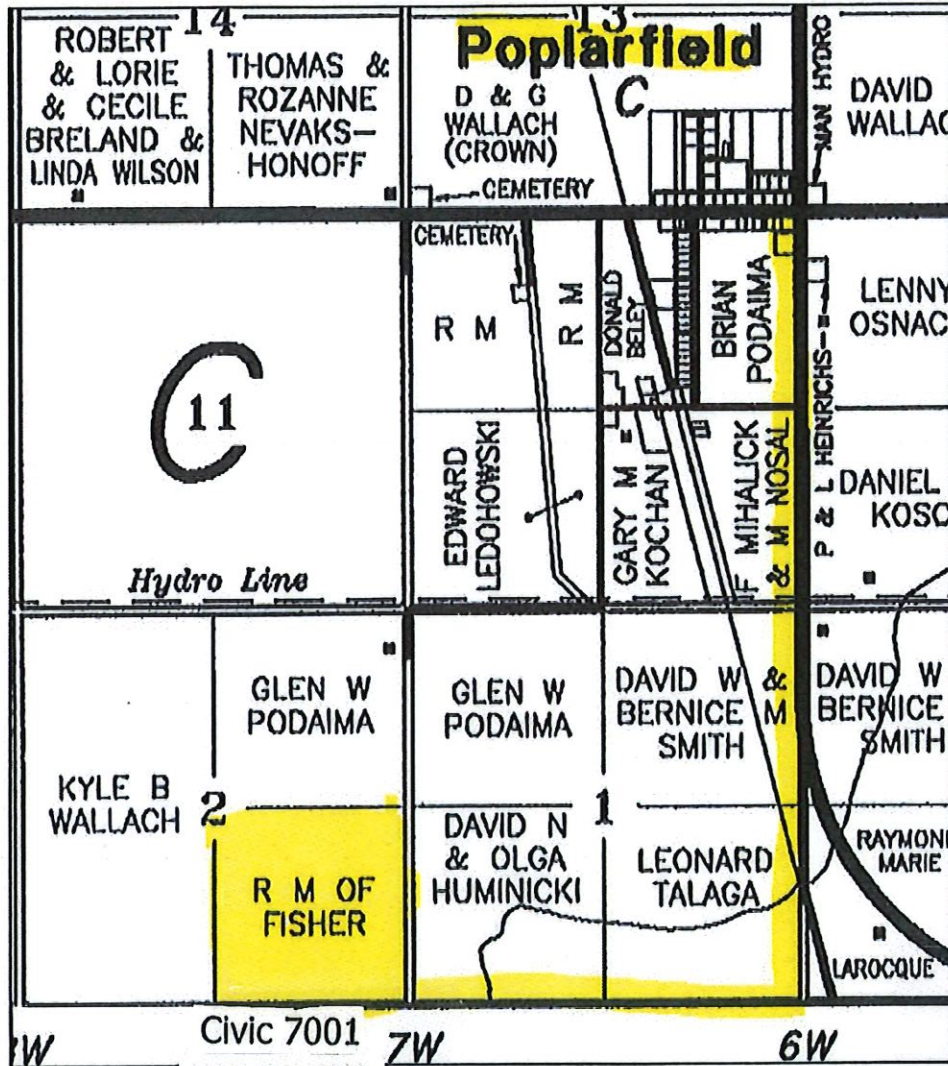

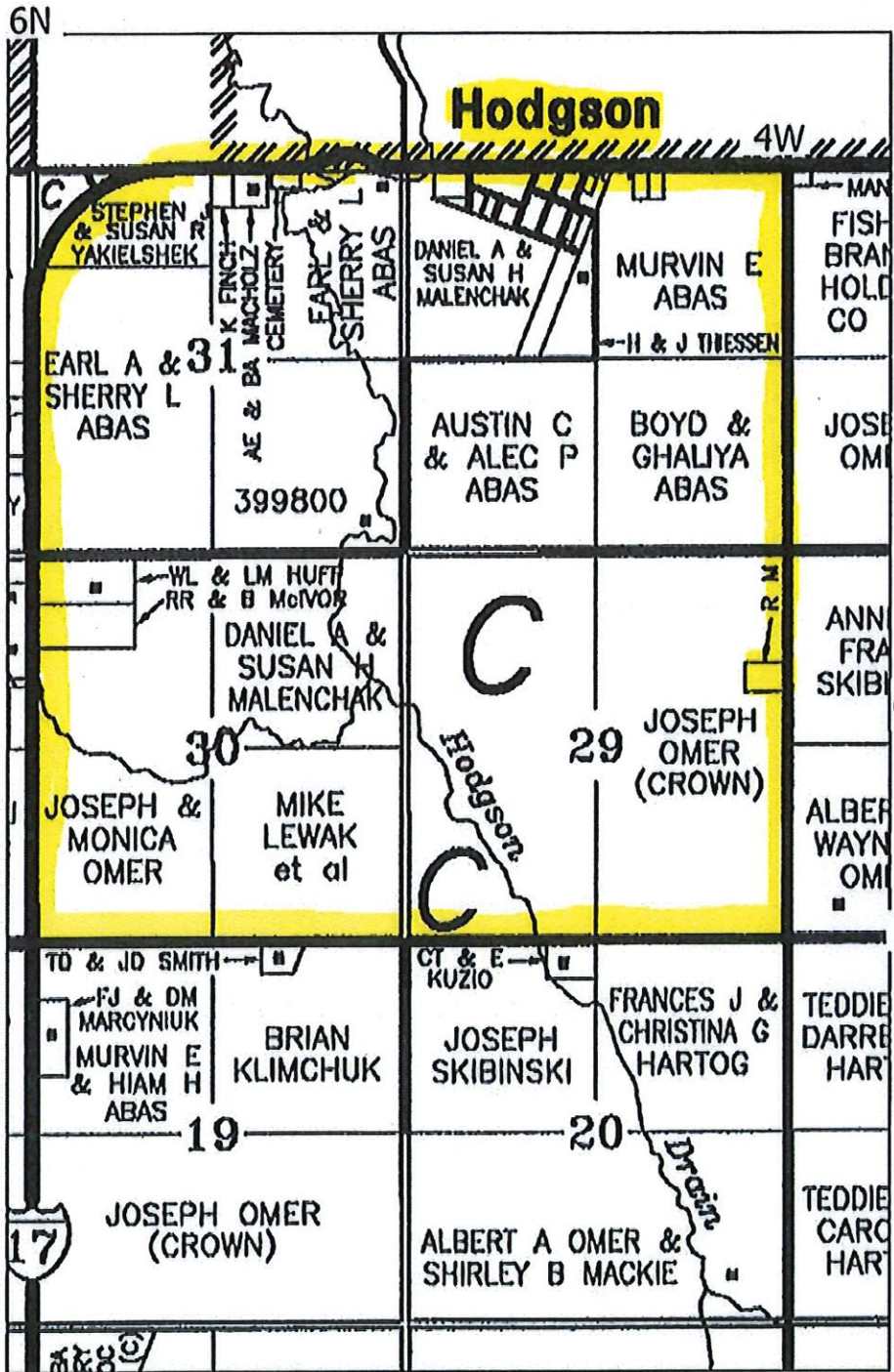

Purpose

The safety, health, protection and well-being of people, and the safety and protection of property in the RM of Fisher.

SCOPE

- a. People and activities in, on or near a public place or place open to the public, including parks, municipal roads, recreation centres, restaurants, facilities, retail stores, malls and private clubs and facilities;
- b. Activities or things in or on private property;
- c. The sale and use of firecrackers and other fireworks, the use of rifles, guns and other firearms and other devices;
- d. Activities or things that in the opinion of the Council are or could become a nuisance, which may include noise and vibrations.

Prohibited Noises

No person shall make, continue to cause, or allow to be made or continued, by whatever means, any Nuisance Noise except where otherwise permitted by this Council.

The following shall be deemed likely to be Nuisance Noise:

- The Sound caused by the lighting and/or setting off of any explosive noise making device, including a firecracker or other fireworks, unless specifically authorized by the Fire Chief or CAO;
- The sound made from scare cannons or cracker shells obtained from Manitoba Conservation for the purpose of scaring wild animals or birds.

COUNCIL POLICY

1. users are required to turn off between the hours of 10:00 pm of any day and 7:00 am of the next following day to prevent from becoming habituated to scare equipment and reduce disturbances to neighbours.
 2. to be situated 400 meters from any residence;
- The property/owner, lessee, occupier or Person in control of a Premises is responsible for Nuisance Noise created by invitees, guests or other persons on the Premises in the same manner as the person actually creating Nuisance Noise unless the property owner, lessee, occupier or Person in control of the Premises establishes that they exercised due diligence in a bona fide effort to control and abate such noise.

CIVIC ADDRESSING PROGRAM

The signs appearing at the end of rural driveways in the RM of Fisher are the new numbering for dwellings and other structures. These numbers are assigned in accordance with the Provincial guidelines for addressing and are tied to the new road naming scheme.

The numbering for structures is based on two factors: i) the “block” of the road segment (e.g. Between Road 144N and Road 145N is Block 144), and ii) the distance that the driveway is located along that road segment. A rural address comprises a number and a road name, just the same as in any community (e.g. 123 Main Street). **The road name and community must be stated to complete the civic number posted at the end of your property.**

IMPORTANT NOTICE

In the case of an emergency dial 911 and give the operator your civic number (located on the blue sign at the end of your driveway), road number (the road number the approach is accessed off of) and the municipality or community you are located in. Example 12345, Road 148N, RM of Fisher and Legal Land Description.

Urban areas within the RM of Fisher have blue civic signs with house numbers located at the end of the driveway. In this case the operator would require a full address such as 123 Tache Street, Fisher Branch, Manitoba.

Please ensure all members of your family know your full address. We recommend posting “your” address in your home near the phone for quick reference. The RM of Fisher will be supplying fridge magnets so that you can post this address for quick easy reference. We will be happy to assist you in completing the information for the magnets.

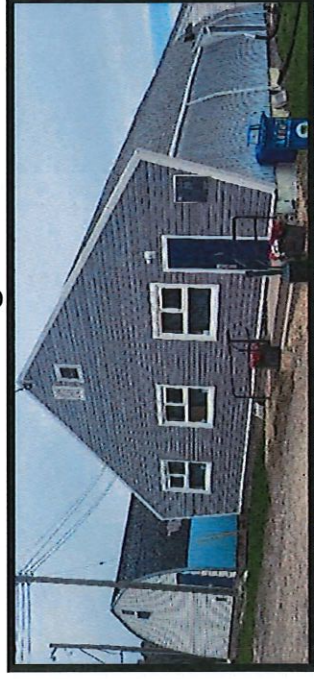
The community is located in the heart of the Interlake, at the intersection of Highway 17 & 68.

Guide to Emergencies

Your Guide to

1. Knowing the Risks
2. Making a Plan
3. Getting a Kit

What to do during:

1. A snow storm
2. Power outages
3. Wildfires
 - Make sure you are safe before helping others
 - Follow your Emergency Plan
 - Get your Emergency kit
 - Monitor radio, television and online for information from authorities. Follow their instructions.
 - Limit phone calls to allow for Urgent messages.
 - Keep the lines free for emergency responders

Severe Storms

- If possible, take shelter in a building and stay indoors.
- Monitor radio, television and online for weather warnings and instructions.
- If time allows secure items that might be blown around or torn loose such as lawn furniture.
- Stay away from windows, doors and fireplaces
- If you are driving, stop your car away from trees or power lines

Blizzards

- Have an Emergency kit ready
- If you must go outside be aware that you can quickly become disoriented and may get frostbite and hypothermia.
- Wear a hooded jacket, hat, mittens and warm footwear.
- If you must travel, do so in daylight hours and let someone know your plans.

If your vehicle gets stuck:

- Stay in your vehicle. Open the window slightly for fresh air. Run the engine for 10 minutes every half hour unless the exhaust pipe is blocked.
- To keep warm, exercise your hands and feet periodically.
- If shovelling, avoid overexerting yourself. Overexertion in the bitter cold can cause death as a result of a heart attack or hypothermia from sweating.
- Keep a lookout for traffic or searchers

Ice Storms

If you are inside:

- Stay indoors unless you are told to evacuate

If you must go outside:

- Pay attention to high branches or wires that could break and fall
- Stay well away from power lines, as hanging wires may be live.
- Avoid driving, until after freezing rain ends to allow for road maintenance. Or check local updates.

Thunder and Lightning Storms

If you are inside

- Unplug radios, TV's and appliances. Use a battery operated or wind-up radio to listen for weather warnings.
- Avoid using a corded phone and stay away from items that conduct electricity
- If there is hail, stay away from windows, glass doors and skylights.

If you are outside

- If caught in the open crouch in the "leap frog" position to minimize ground contact. Do not go under a tree.
- If you are driving, stop your vehicle away from trees or power lines
- If you are on the water, head for the shore immediately

Tornadoes

If you are inside:

- If you are in a high-rise, do not use the elevator
- Go to the basement or small interior ground floor room. Take shelter under a table or desk.
- Stay away from windows, outside walls, fireplaces and doors.
- Avoid using a corded phone and stay away from items that conduct electricity
- Limit phone calls to urgent messages only.

If you are outside:

- If time permits, go to the nearest solid shelter. If not, take cover in a low-lying area such as a ditch and protect your head. Beware of flooding and downpours and be prepared to move.
- Do not take shelter under a bridge as winds can accelerate
- Do not take shelter in a mobile home that does not have a solid foundation.

Power Outages

- Check if the power outage is limited to your home. If your neighbours have power, check your circuit breakers.
- If your neighbours power is also out, contact hydro.
- Turn off all tools, appliances, electronics. All but one light inside or outside.
- Use your thermostat to turn off heating or air conditioning.
- Avoid opening your fridge or freezer
- Do not use barbeques, camping heating equipment, or home generators indoors. They can produce dangerous levels of carbon monoxides.
- Monitor a crank or battery-operated radio for weather warnings and instructions from authorities.
- If you use candles please ensure you have them in proper holders and extinguish before going to bed.

When the power returns

- In cold weather, turn heating back on first, then wait before reconnecting everything else.
- Check food supplies. If a freezer door has been kept closed, food should stay frozen for 24 – 36 hours. Food contaminated with bacteria does not necessarily smell or look bad. When in doubt throw it out.

Wildfires

- Be prepared to evacuate at any time, if told to evacuate. Take your emergency kit with you.
- Monitor radio, television or online for possible road closures and instructions from authorities.

If you have time:

- Close all windows and doors
- Move combustible material such as light curtains and furniture away from windows.
- Turn on lights in the house, porch, garage to aid visibility.
- Turn off propane or natural gas
- Move all combustibles outside away from the house, including firewood, propane barbeques and lawn furniture.
- Cover vents, windows and other opening of the house with duct tape and or precut pieces of plywood.
- Park your vehicle positioned forward out of the driveway. Keep windows closed and pack valuables and your emergency kit in the vehicle.

Evacuation Order

If ordered to evacuate:

- Follow instructions from authorities
- Take your emergency kit, plan, medication, wallet identification and cell phone.
- Shut off water, electricity and gas if instructed to do so.
- Notify your out of town contact and leave a note inside indicating when you left and where you are going if time permits.
- Lock your home
- Use specified routes and pay attention to information on road closures. Stay off any identified: disaster response routes which are for emergency responders only.
- Do not cross a flooded area by foot or in a vehicle. If your vehicle stalls in fast rising water, abandon it.
- Register with a local reception centre in person or by phone.
- Do not return home until authorities advise it is safe

Emergency Preparedness for Children

- Teach children about natural hazards such as earthquakes, tornadoes, severe thunderstorms, ice storms and blizzards and what to do when they occur.
- Make a family emergency plan and prepare an emergency kit together.
- Teach your children what to do in case of a fire.
- Make sure your kids know what to do at school if an emergency happens

Helping Kids Cope

- Children in particular can feel the stress deeply and may react in different ways. The key to helping children cope is simply by being there and making them feel safe.
- Take their fears seriously and tell them that it's okay to be scared.

- Explain the events as best you can and acknowledge what's happening.
 - Tell your children what you think and feel. Doing so helps them feel less alone if they know that their feelings are similar to yours.
 - Maintain familiar routines like mealtimes and regular bedtime hours.
 - While parents can play a huge role in helping children deal with anxiety, it may be helpful to talk to a professional such as a psychologist or social worker, who can help children understand and cope with their emotions.
- Did you know:**
- Younger children may cry, whine or wet the bed in emergency situations.
 - Older children may experience an intense fear of injury or separation anxiety.
 - Other common reactions include a fear of the dark, physical pain and eating or sleeping problems.

Pets and Service Animals

Preparing for emergencies

The following steps will help keep pets safe

Identify your pet

If you become separated from your pet during an emergency, their identification may be the only way to find them. Make sure each animal wears a collar and identification tag at all times.

Pet Emergency Kit

- *A Sturdy crate or carrier*
- *A strong leash or harness*
- *ID tag and collar*
- *Food and water for at least 72 hours (4 litres per dog per day & 1 litre per average cat)*
- *Bowls and can opener*
- *Newspaper, paper towels, plastic bags, litter and/or litter box*
- *Special medications, dosages and vet's contact information*
- *Pet file*
- *A pet first-aid kit (same as human kit)*
- *Blanket and toy*

Plan for evacuations:

The best way to protect your pet in an emergency is to bring it with you. Most evacuation shelters will only accept service animals. Make a list of where your pet can be taken in case you need to evacuate. This list can include:

- Hotels that accept animals even during emergencies
- Boarding shelters and animal shelters
- Animal clinics
- Family members and friends. Include your pet in your family emergency plan exercises.

During an Emergency

Keep your pet inside during severe weather. Animals are very sensitive to sudden changes in temperature and often isolate themselves when scared. Never leave a pet outside or tethered during a storm.

Separate cats and dogs. Keep smaller pets such as hamsters away from larger animals. Stress can lead to unusual behaviour.

Keep newspaper inside for hygiene purposes and feed your pet wet food in order to reduce the amount of water it may need.

If ordered to evacuate, try to take your pet with you. If you must leave your pets in the house, do not tether or cage them. Leave a sign in the window and a note on the door indicating what animals are inside. Provide water and food in timed dispensers. Leave toilet seats up.

Emergency Kit

- *Water – at least 2 litres per person per day*
- *Food that won't spoil, such as canned food, energy bars and dried foods*
- *Manual can opener*
- *Crank or battery-powered flashlight (and extra batteries)*
- *Crank or battery powered radio*
- *First aid kit*
- *Extra keys (vehicle and home)*
- *Cash in smaller bills*
- *A copy of your emergency plan and contact information*
- *Special items such as prescription medication, infant formula and equipment for people with disabilities.*

Keeping in Touch in Emergencies

Being able to communicate with family, friends and emergency responders during an emergency is critical. However, keep in mind that everyday communication devices may not work properly during an emergency.

If possible, use non voice channels like text messaging, email or social media, as these use less bandwidth than voice communications and may work even when phone service has been disrupted.

If you must use a phone, keep your conversation brief and convey only vital information. Keeping your calls short also saves battery life on your mobile phone.

If you are unable to complete a call wait 10 seconds before redialing to help reduce network congestion.

Keep extra batteries or a charger for your mobile device in your emergency kit. Consider getting a solar powered, crank or vehicle phone charge, or if you do not have a cell phone, keep a prepaid phone card in your kit.

If you have been evacuated and have call forwarding on your home phone, use it to forward calls to your cell phone.

If you do not have a handsfree device in your car, stop driving or pull over to the side of the road before texting, making a call or using the device.

Keep your contacts up to date on your phone email and other channels.

Note, cordless phones rely on electricity and will not work during a power outage. If you have a landline keep at least one corded phone in your home.

Additional tips for smartphones:

Save your safe meeting locations on your phone mapping application.

Conserve your battery by reducing the screen's brightness and closing apps you are not using.

To reduce network congestion immediately after an emergency, avoid using your mobile device to stream videos, download entertainment, or play video games.
