Administration has reported that Public Works has been instructed to fill up all machinery, and went over emergency backup plan. Utility Operators have been given masks and gloves and went over emergency backup plan. Office will be closing its doors to the public and if need be taking shift so only one will be working in the office at a time. All employees are to stay home if sick. Backups for administration are in place. Disposal sites are on stand by for closure. Councillors have been forwarded emergency snow plow medical lists and office staff will be contacting individuals to do a welfare check. Website will be updated regularly to provide as much up to date factual information as possible.
