10:30 Public Hearing – Glacier North Limited CU 20-25

Pursuant to sections 169 and 170 of the Planning Act with respect to By-Law 1055/00 to issue a conditional use permit for the NE 25-22-2W currently zoned AG (agricultural) to a conditional use of natural resource development (aggregate quarry).

74/25 **RESOLVED THAT** the Council meeting adjourn at 10:30 a.m. and that Council resolve into a Public Hearing to hear all presentations, written and verbal to issue a conditional use for a conditional use of natural resource development (aggregate quarry).

Chairperson Shannon Pyziak began the hearing at 10:30 a.m. to hear representation, answer questions, or receive objections to the conditional use application under By-Law 1055/00.

Proof of notice was provided by recording secretary, Kelly Marykuca

3 people were in attendance. Ken Stadnek, Dan Kosc, Wendy Yuzwa.

Ken Stadnek was in attendance to make representation for the conditional use application. Ken stated that the proposal is to start a gravel pit and granular material. They have a potential contract with Tria Products. Existing access on property to Highway 17. Access to property approved by Dan Kosc. Will discuss with Broad Valley Colony about access to property via their lease. They will be blasting 400 meters from the nearest residence. Company out of Stonewall - they will be performing the blast with a seismograph. No crushing will take place on the

weekend. Council can determine the appropriate hours for crushing. Will agree to a Road Haul agreement if required. Depth of quarry will be maximum 20 feet. If pumping is needed they will obtain a water license.

No written representation was received.

Wendy Yuzwa was in attendance to express concerns of the conditional use. She is concerned if her well will collapse. Her well is about 40 to 50 feet. Also if there are any windows or structural problems to the home after blasting. She also would like to be notified of the date and time of the blast.

Chairman Shannon Pyziak declared the receipt of presentations complete and conclude the Public Hearing at 10:58 a.m.

THEREFORE BE IT RESOLVED THAT conditional use for natural resource development on the NE 25-22-2W be approved and

BE IT FURTHER RESOLVED THAT the following conditions apply:

- Crushing take place Monday to Friday from 7 a.m. to 7 p.m. only
- If water requires to be pumped from quarry a water right license needs to be obtained from the Province of Manitoba
- Damaged infrastructure relating to blasting within a 1 (one) mile radius of blast, which includes nearby wells, windows and structures be remedied by Glacier North Limited.
- Private wells to be tested prior to work being started is the responsibility of Glacier North Limited (Yuzwa and Podaima)
- Blast be directed west by certified blaster
- Residence within 1 (one) mile be notified before blast
- Municipal roads utilized by Glacier North Limited or customers thereof be subject to Municipal Road Haul Agreements

Northern Trailblazers

Dustin Cymbalisty made representation for the Northern Trailblazers club.

He has come to Council for a solution for the Texas Gate located on the Interlake Pioneer Trail. The Groomer cannot go over the gates there, breaking numerous cleats. There are 2 (two) gates located on the trail.

Dan Kosc, owner of the Texas gates was also present. Mr. Kosc stated that he has never been reimbursed for the \$975.00 for repairs made in the past where the groomer took our part of his fence. Councillor Lindal to contact the Interlake Pioneer Trail for Kosc's reimbursement as it happened before the municipality took ownership. Mr. Kosc to make up invoice and give to the RM. Mr. Kosc stated Texas gate can be cut and reconfigured.

Council decided on the following options:

- Gate to be straightened to remove hump (Ok with Mr. Kosc) and reinstalled by the snowmobile club. Specifications remain in place. Club to be responsible for cattle getting out and crop damage.
- Snowmobile club can go around using the nearby crown land
- Bury the gate with snow to create a passible ramp

Mr. Kosc and Northern trailblazers to receive criteria via written letter.

Signed contract for trail usage is required.
